Non-degree-seeking Track

This form is for students who do not intend to become degree-seeking in the future. DAY CAMPUS STUDENTS ALSO SHOULD USE THIS FORM.

Direct Access Policies

The Direct Access Program is designed for non-degree evening students who wish to take individual courses while not actively pursuing a degree and those who need to take courses to earn additional credentials to become degree-seeking in the future. Students may register for a maximum of six hours in the two eight-week sessions in fall and spring, and three hours in the summer. Graduate credit is not allowed through Direct Access.

The following policies govern the registrant in Direct Access:

- 1) Students on dismissal status from any institution, including the University of Missouri-Columbia, are not eligible to register until one year has elapsed.
- 2) Students must be high school graduates.
- 3) Students may not transfer into a degree-granting division of the University during the session in which they are enrolled in Direct Access.
- 4) Transfer into a degree-granting division of the University requires completion of the regular application process.
- 5) Registration is open on a space-available basis.
- 6) Students enrolling in Direct Access will not normally be eligible for federal financial aid, since this form of registration is non-degree in orientation.
- 7) The Office of the University Registrar serves as the "Dean's Office" for Direct Access students.

- 8) No graduate credit is available through Direct Access.
- 9) Fees for students enrolling through Direct Access are the same as those for regularly admitted students. (Fees are payable the day of enrollment.)
- 10) International students will be required to provide proof of a TOEFL of 500 or better.

 Any high school graduate, if not currently enrolled in the University of Missouri-Columbia, is eligible to participate in the program. Students on dismissal status from MU or any other institution are not eligible to participate in this program until one year has elapsed since their dismissal.

18. Enrollment
 Direct Access students may enroll only as part-time students (no more than six hours in the two eight-week sessions in Fall and Winter and three hours in the Summer session.) Students who have completed course work at another institution within the last 12 months must provide evidence of "good standing" or eligibility to re-enroll. (Evidence of good standing or eligibility to re-enroll should be sent to the MU Admissions Office and must be received prior to the close of the third week of classes or your enrollment in MU will be cancelled.) Students enrolling via Direct Access may not transfer into a school or college during the session in which they are enrolled under Direct Access. (See back of this form for all policies governing Direct Access.)

Failure to complete this form fully and accurately will void your admission. Providing misinformation concerning enrollment in other colleges or universities also will void your admission.
